- 3. An additional counter affidavit has been filed by the State Government seeking to rely on the very same provision of Section 28 of the PCA to claim as if camel slaughtering is permitted as a special measure, coupled with the fact that religious ceremony permits the slaughtering of camel. We may only add here that the admitted position is that there are no camels available in Tamil Nadu and thus, a comparison cannot be made of areas where camels are found easily. In fact, camels are imported into Tamil Nadu from Rajasthan, Gujarat and Maharashtra. It has been emphasised before us that these camels are found really in the border areas of those States which are deserts.
- 4. Rajasthan is stated to have prohibited even the export of camels out of the State for the purposes of slaughter by an enactment.
- 5. The affidavit of State Government also shows that the existing abattoirs are not used for slaughtering of camels and it is affirmed that camels are slaughtered for food during Bakrid festival alone and not eaten during the whole year.
- 6. It is trite to say that the slaughtering of camels cannot be the same as the slaughtering of goat. There is, thus, no facility in Tamil Nadu for proper slaughtering of camels were it to be permitted.
- 7. The mode and manner of transport of animals has also been set out by reference to different rules, but there are also rules applicable under different Central Enactments, which would have to be taken into consideration, including PCA. The affidavit now states that animals even when transported, should be given adequate rest, food and water. The examples which earlier came before us are both of camels that were brought by transportation and by foot.
- 8. One of the aspects referred to in the affidavit is that any area can be declared as slaughter house by the Commissioner of Corporation under the Chennai City Municipal Corporation Act, 1990. This however, cannot be said to supersede the Central Act Prevention of Cruelty to Animals Act, 1960.
- 9. In one of the petitions, W.P.No.28899 of 2015, a challenge is sought to be laid to the circular issued under the Food Safety and Standards Act, 2006 (FSS Act) and Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011. That will be an aspect to be examined by us at the stage of final hearing of writ petition.
- 10. We are thus of the view that the matter should be set down for final hearing, but in the mean time, in view of the stand of the Central Government and the provisions of the Central Act including PCA, we cannot have a situation where such camel slaughtering is permitted especially in the absence of any facility for it. Ordered accordingly.

(iv) Issue appropriate writ orders or directions and in particularly writ of certiorarified mandamus to Call for the records from the respondent pertaining to the impugned Circular No.9-2/2015-16-PCA dated 17.8.2015 issued by the 1st respondent and quash the same and consequently forbearing the respondents from interfering with religious ceremonies/festivals of the Muslim Community (in WP.28899/2015) respectively.

The Union of India has finally filed its affidavit and the categorical assertion is that Section 28 of the Prevention of Cruelty to Animals Act, 1960 (PCA) does not support sacrifice of animals. Destruction of animals is allowed for food of mankind only and not for sacrifice purposes. It has also been affirmed that under the Food Safety and Standards (Food Products Standards and Food Additives) Regulation, 2011, a notification has already been issued prohibiting Camel meat as food. To prevent unnecessary pain or suffering, the Central Government has enacted the following Acts and Rules which have been set out in paragraph-6 of the affidavit.

- I. Prevention of Cruelty to Animals Act, 1960.
- II. The Prevention of Cruelty to Animals (Slaughter House) Rules, 2001 and as amended in 2010.
- III. The Prevention of Cruelty to Animals (Transport of Animals on Foot) Rules, 2001.
- IV. The Prevention of Cruelty to Animals (Transport of Animals) (Amendment) Rules, 2009.
- V. The Transport of Animals Rules, 1978 and as amended in 2001.
- The affidavit in fact, prays for direction to the State Government to enforce the PCA and the Rules made thereunder, both for prevention of illegal transport and slaughtering of animals.

- (i) Issue a Writ of Mandamus or any other Writ, Order, or Direction in said nature directing the respondents 1 to 4 to prevent any transport of Camels into the State of Tamilnadu by foot or on vehicles without compliances to the transport rules and their killing as religious sacrifices inside Tamilnadu in violation of Rules for slaughter of animals, in places other than lawful slaughter houses, in accordance with rules (in WP.No.13749/15) and ;
- (ii) Issue a Writ, Order, or Direction in the nature of a writ more particularly writ of Mandamus directing the respondents to take effective steps to prohibit the illegal transportation & slaughtering of camels in the state of Tamil Nadu (in WP.No.11519/15);
- (iii) "Issue a Writ of Mandamus or any other writ, order, direction in the said nature directing the respondents to ensure that no destruction, killing or sacrifice of any nature, of any animal takes place in the State of Tamil Nadu outside a registered and licensed slaughter house and that such killing or destruction of animals is only for arranging for food for mankind" (in WP.13748/2015);
